Any child opting for French instruction in Kindergarten or from Grade 1- 6 may apply for an authorization to receive English instruction which may be useful for the child if he or she wants to change section in the Elementary school or opting for English High school. In the case of children applying for the English section in Kindergarten-Grade 6, a parent must sign the appropriate application form for English eligibility.

(i) For parent(s) born in Québec and who had English Instruction in Québec:

- (b) Short Form to be signed by parent
- (c) Valid passport of that parent who received English instruction in Québec
- (d) Copy of the English Eligibility certificate of the parent or sibling

- (d) Valid passport of that parent who received English instruction in Canada
- (e) Copy of the English Eligibility certificate of the parent or sibling (if applicable)

(iii) For parents who have a temporary stay in Québec

- (a) Identification form duly completed
- (b) Form 2 (*sections 1 to 6 to be completed depending on the criterion invoked in support of application*) to be signed by parent
- (c) Valid passport of parents
- (d) Copy of parent marriage certificate
- (e) If the birth certificate of the child is in another language, it should be translated by an authorized body (e.g. Embassy) in English/French
- (f) Copy of work permit and/or copy of any scholarship agreement contract, etc.
